

1 [Affirm certification of the final environmental impact report for the Golden Gate Park  
2 Concourse Authority Projects.]

4 **Motion affirming the Planning Commission certification of the final environmental**  
5 **impact report for the Golden Gate Park Concourse Authority Projects.**

7 WHEREAS, The Golden Gate Park Concourse Authority, project sponsor for an  
8 underground parking facility on part of Assessor's Block 1700, Lot 1 within Golden Gate Park  
9 (Phase I), related surface improvements to the Golden Gate Park Music Concourse area, an  
10 underground through street (Phase II), and various transportation improvement measures  
11 (collectively, the "Projects") submitted its application for environmental review of the Projects  
12 to the San Francisco Planning Department (the "Department"); and

13 WHEREAS, The Department created City Planning File No. 2001.9115E, subsequently  
14 determined that an environmental impact report was required for the Projects, and provided  
15 public notice of that determination by publication in a newspaper of general circulation on May  
16 18, 2002; and

17 WHEREAS, On December 14, 2002, the Department published a draft environmental  
18 impact report (the "DEIR") and provided notice of the availability of the document for public  
19 review and comment. A copy of said document is on file with the Clerk of the Board of  
20 Supervisors in File No. 031481 and is incorporated by reference herein; and

21 WHEREAS, On January 23, 2003, the Planning Commission (the "Commission") held a  
22 duly noticed public hearing on the DEIR; and

23 WHEREAS, On January 28, 2003, the 50-day public comment period on the DEIR  
24 ended; and

1           WHEREAS, On July 3, 2003, the Department published a "Draft Summary of  
2 Comments and Responses" on the DEIR and distributed such document to the Commission  
3 and to all parties who commented on the DEIR. A copy of said document is on file with the  
4 Clerk of the Board of Supervisors in File No. 031481 and is incorporated by reference herein;  
5 and

6           WHEREAS, Prior to publication of the Draft Summary of Comments and Responses,  
7 the Project Sponsor's Executive Director notified the Planning Department that the preferred  
8 project as analyzed in the DEIR had been revised. The revised project, identified and  
9 analyzed in the DEIR as Alternative B, consists only of Phase I, the underground parking  
10 facility, and the transportation improvement measures (the "GGPCA Preferred Alternative").  
11 Phase II, the underground through street, is not part of the GGPCA Preferred Alternative; and

12           WHEREAS, On July 17 and 24, 2003, the Commission, at a duly noticed public  
13 hearing, considered the certification of the final environmental impact report (the "FEIR"),  
14 which consists of the DEIR, the Draft Summary of Comments and Responses, and related  
15 documents; and

16           WHEREAS, On July 24, 2003, in Motion No. 16620, the Commission certified the FEIR  
17 finding that the contents of the FEIR and the procedures through which it was prepared,  
18 publicized, and reviewed complied with the provisions of the California Environmental Quality  
19 Act (Cal. Public Resources Code sections 21000 et seq., hereinafter "CEQA"), the State  
20 CEQA Guidelines (Cal. Code of Regulations Title 14, sections 15000 et seq., hereinafter  
21 "CEQA Guidelines") and Chapter 31 of the San Francisco Administrative Code ("Chapter 31");  
22 and

23           WHEREAS, By said Motion No. 16620, the Commission found the FEIR reflected its  
24 independent judgment and analysis and was adequate, accurate, and objective, and certified  
25 the FEIR in compliance with CEQA, the State CEQA Guidelines, and Chapter 31. Said

1 Motion is on file with the Clerk of the Board in File No. 031481 and is incorporated by  
2 reference herein; and

3 WHEREAS, By separate letters to the Clerk of the Board of Supervisors dated August  
4 13, 2003, Stephen L. Willis and the Alliance for Golden Gate Park filed timely appeals of the  
5 FEIR certification to the Board of Supervisors; and

6 WHEREAS, On September 16, 2003, this Board held a duly notice public hearing to  
7 consider the appeal of the FEIR certification; and

8 WHEREAS, This Board has reviewed and considered the FEIR and heard testimony  
9 and received public comment regarding the adequacy of this document; and

10 WHEREAS, The FEIR files and all correspondence and other documents have been  
11 made available for review by this Board and the public. These files are available for public  
12 review by appointment at the Planning Department offices at 1660 Mission Street and are  
13 made part of the record before this Board by reference herein; and

14 WHEREAS, Since the Planning Commission action on the FEIR, there is no new  
15 information of significance that would require a substantial revision to the FEIR and  
16 necessitate recirculation of said document pursuant to CEQA Guideline section 15088.5; now,  
17 therefore, be it

18 MOVED, That based on substantial evidence in light of the whole record, this Board of  
19 Supervisors finds that : 1) the FEIR reflects its independent judgment and analysis and is  
20 adequate, accurate, and objective; 2) the FEIR's conclusions are correct; and 3) the findings  
21 contained in the Planning Commission certification are correct; and this Board hereby affirms  
22 the decision of the Planning Commission in its Motion No. 16620 to certify the FEIR in  
23 compliance with CEQA, the State CEQA Guidelines, and Chapter 31.


