**Resolution endorsing those changes and providing findings as to the local conditions requiring amendments to the State Mechanical Code, as required by California Health and Safety Code.**

WHEREAS, The Board of Supervisors is enacting a Mechanical Code for the City and County of San Francisco to be known as the "2001 San Francisco Mechanical Code"; and

WHEREAS, The aforesaid San Francisco Mechanical Code differs in part from the State Mechanical Code for buildings; and

WHEREAS, California Health and Safety Code Section 17958.5 requires the City to furnish to the California Building Standards Commission reasons for amending the State Mechanical code based upon local conditions; and,

WHEREAS, A specific section by section statement of the reasons for each amendment is set forth in that certain document in the Board of Supervisor's file No. 021208 \_\_\_\_\_ identified therein and hereinafter referred to as Exhibit A; and

WHEREAS, The Board of Supervisors has reviewed the statement of reasons set forth for each amendment in said Exhibit A; and

WHEREAS, The Board of Supervisors finds and determines that these differences in the San Francisco Mechanical Code are necessary because of local conditions for the reasons set forth in Exhibit A; now therefore be it

RESOLVED, That the Board of Supervisors does hereby find and determine that the aforesaid changes to the San Francisco Mechanical Code are necessary because of local conditions for the reasons set forth in Exhibit A; and be it


