12 growth and sustainable development for the Bay Area; and,

13 WHEREAS, the five regional agencies want to build on the strengths of local leadership  
14 and organizational capacity to ensure a process with integrity and to increase the likelihood of  
15 results; and

16 WHEREAS, two county-wide workshops have been scheduled in San Francisco for the  
17 combined regional agencies on Saturday, October 13, 2001 and in February/March 2002,

19 WHEREAS, the City and County of San Francisco has been requested to co-sponsor  
20 the two workshops; and

21 WHEREAS, co-sponsorship includes permission to include the City and County of San  
22 Francisco's name on the workshop announcements and materials, cooperate in designating a  
23 representative of the organization to co-sign correspondence related to the workshop; and,  
24 encourage participation and mobilization of the Board members to attend the workshop; and

2 Supervisors in File No. 011422, which is hereby declared to be a part of this motion as is  
3 set forth fully herein; now, therefore, be it moved, that the Board of Supervisors approves co-


