3 **Resolution authorizing the Public Health Department to accept a gift of a Data Center**
4 **and an Electronic Medication Administration Record System for the San Francisco**
5 **General Hospital (SFGH) from the San Francisco Hospital Foundation (SFGH**
6 **Foundation).**

8 WHEREAS, the Department of Public Health’s (DPH) Information Systems Department
9 currently operates and maintains 120 servers which support the direct patient care activities of
10 the staff at San Francisco General Hospital (SFGH); and

11

12 WHEREAS, the demand for additional clinical systems exceeds the capacity of the
13 current data center and software upgrades for patient care related functions cannot be
14 installed due to insufficient server capacity; and

15

16 WHEREAS, DPH can not expand existing space due to lack of supply, insufficient
17 funding and the inability to co-locate servers due to requirements that critical care systems be
18 on site; and

19

20 WHEREAS, the best solution is a mobile data center; and

21

22 WHEREAS, SFGH is converting the existing medication administration system to a
23 completely electronic system that will provide real time documentation capabilities and enable
24 better clinical decision making and more accurate communication between

1 providers, nursing and pharmacy staff and minimize medication errors; and

2

3 WHEREAS, a software product is available that is compatible with SFGH's Pharmacy
4 software and it will eliminate the need for the nursing staff to transcribe provider orders by
5 hand; and

7 WHEREAS, the Gordon and Betty Moore Foundation has given the SFGH Foundation
8 a gift of \$2,262,000 for purchase and installation of a data center and an eMAR product for
9 SFGH; and

10

11 WHEREAS, DPH wishes to obtain approval from the Health Commission and the
12 Board of Supervisors to accept a gift of a data center and an Electronic Medication
13 Administration Record System for the San Francisco General Hospital from the
14 the San Francisco General Hospital Foundation; and now, therefore; be it

15

16 RESOLVED, that the Department of Public Health, is hereby authorized to
17 accept this gift in accordance with the requirements set forth pursuant to San
18 Francisco Administrative Code Section 10.100-305, and Code Section 10.100-201;
19 and, be it

21 FURTHER RESOLVED, that the Department of Public Health is hereby
22 authorized to accept a gift of a data center and an Electronic Medication Administration
23 Record System for the San Francisco General Hospital from the San Francisco General
24 Hospital Foundation
