3 following the holiday, and regular meetings shall not be scheduled during the first weeks of  
4 March, April (in honor of the birthday of Cesar Chavez), June and August.]

5 **Supervisors nor any of its Committees shall convene regularly scheduled meetings**  
6 **during the week of the first Tuesday of each month weeks when a holiday occurs, effective**  
7 **beginning the week of May 26, 2003, except that regularly scheduled Board and Committee**  
8 **meetings may be held on Monday through Wednesday of Thanksgiving week, and regular**  
9 **meetings shall not be scheduled during the week following Thanksgiving, nor during the first**  
10 **weeks of March, April (in honor of the birthday of Cesar Chavez), June and August.**

12 WHEREAS, By Resolution No. 675-02 the Board of Supervisors established Tuesdays  
13 at 2pm as the regular meeting days and times of the Board of Supervisors, beginning on  
14 February 4, 2003; and

15 WHEREAS, In recognition of the City's budget problems and the possibility that City  
16 staff may be taking work furlough days for the foreseeable future, the Board's schedule should  
17 reflect the need to allow furlough days to be taken without adversely affecting the work  
18 schedule of the Board and its Committees, the Board of Supervisors now wishes to amend  
19 Resolution No. 675-02 to provide that neither the Board nor its Committees shall convene  
20 regularly scheduled meetings during the week of the first Tuesday of each month; now,  
21 therefore, be it

22 RESOLVED, That Resolution No. 675-02 is hereby amended to add the following  
23 paragraph

24 "RESOLVED, That neither the Board of Supervisors nor any of its Committees shall  
25 convene regularly scheduled meetings during the week of the first Tuesday of each month,

1 effective with the week of May 6, 2003 weeks when a holiday occurs, effective beginning the  
2 week of May 26, 2003, except that regularly scheduled Board and Committee meetings may  
3 be held on Monday through Wednesday of Thanksgiving week, and shall not be scheduled  
4 during the week following Thanksgiving. In addition, neither the Board nor any of its  
5 Committees shall convene regularly scheduled meetings during the week of the first Tuesday  
6 of March, June and August. Further, neither the Board nor any of its Committees shall  
7 convene regularly scheduled meetings during the week of the first Tuesday of April, in honor  
8 of the birthday (March 31) of Cesar Chavez."


