2 **URGING THE CALIFORNIA SENATE AND ASSEMBLY TO SUPPORT AND PASS**
3 **ASSEMBLY BILL 1796, AUTHORED BY ASSEMBLYMAN LOU PAPAN, AMENDING**
4 **CALIFORNIA PENAL CODE SECTION 890 RELATING GRAND JURIES.**

5 WHEREAS, Current law provides that unless a higher fee or rate of mileage is
6 otherwise provided by statute or county or city and county ordinance, the fees for grand jurors
7 are \$10 per day for each day's attendance as a grand juror, and 15 cents a mile, in going only,
8 for each mile actually traveled in attending court as a grand juror; and

9 WHEREAS, Assembly Bill 1796, introduced by Assemblyman Lou Papan, would
10 instead provide that unless a higher fee or rate of mileage is otherwise provided by statute or
11 county or city and county ordinance, the fees for grand jurors are \$25 a day for each day's
12 attendance as a grand juror and the mileage reimbursement applicable to state employees for
13 each mile actually traveled in attending court as a grand juror; and

14 WHEREAS, Given that the compensation fee for participation as a grand juror has not
15 increased since 1971 and mileage reimbursement for grand jurors has not increased since
16 1959, the proposed are not only long overdue and commensurate with the current cost of
17 living; now therefore be it

18 **RESOLVED**, That the Board of Supervisors of the City and County of San Francisco
19 hereby urges the California Senate and the Assembly to support and pass AB1796, authored
20 by Assemblyman Lou Papan, amending California Penal Code Section 890 relating to grand
21 juries.
