Since we are unable to attend the meeting on Tuesday, July 8, we are writing to you instead as tenants of 2550 Ocean Avenue in Lakeside Village. We urge you to support the renewal and expansion of the Ocean Avenue Association.

Our building was previously a Walgreens that shut down during the pandemic. After years of vacancy, we invested heavily to renovate and revitalize the space to serve as our Ministry Center. We opened on September 29, 2024, and have been able to serve the local neighborhood and surrounding community through recovery, youth programs, outreach and more.

The OAA provided important services to us as tenants in Lakeside Village. Early in the morning, Roland and the OAA cleaning team were proactive about gently moving unhoused individuals living in our doorway and cleaning up after them. The OAA picked up litter and power-washed sidewalks. They even weeded sidewalk gardens, including the ones outside our property. The OAA's work increased the safety of families and volunteers utilizing our Ministry Center.

As you are well aware, following the financial ruin of Parks Alliance, OAA services were paused in early May. This has made operating on Ocean Avenue more difficult for us and our team.

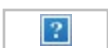
