8 WHEREAS, The Department of Public Health desires to continue to capture revenue
9 through the retroactive claiming of aged accounts services with Triage Consulting Group to
10 assist in the identification and billing of accounts eligible for retroactive recovery, when
11 available sources were not previously identified by the Department; and,


12 WHEREAS, The revenue collected by said contract will exceed one million dollars
13 (\$1,000,000); and,

14 WHEREAS, Section 9.118 of the San Francisco Charter requires that such contracts
15 be approved by the Board of Supervisors; now, therefore, be it

16 RESOLVED, That the Board of Supervisors hereby/^{retroactively}authorizes the Director of Public
17 Health and the Director of the Office of Contract Administration/Purchaser, on behalf of the
18 City and County of San Francisco, to execute a contract with Triage Consulting Group for the
19 period July 1, 2008 through June 30, 2012 to provide retroactive claiming of aged accounts
20 services; and, be it

1 FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the Director
2 of Public Health and the Director of the Office of Contract Administration/Purchaser to make
3 amendments to this contract, if needed.


