3 **Ordinance authorizing settlement of the lawsuit filed by Scott Crayne against the City**  
4 **and County of San Francisco for \$45,000; the lawsuit was filed on April 19, 2021, in San**  
5 **Francisco Superior Court, Case No. CGC-21-591124; entitled Scott Crayne v. City and**  
6 **County of San Francisco, et al.; the lawsuit involves an alleged personal injury on a**  
7 **City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Scott Crayne v. City and County of  
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-591124 by the  
13 payment of \$45,000. The lawsuit involves an alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 April 19, 2021, and the following parties were named in the lawsuit: Plaintiff Scott Crayne;  
16 Defendants City and County of San Francisco, Bancal Management Corporation; Cross-  
17 Defendant 346 First Street Owners' Association.
