Section 1. Findings.

The Planning Department has determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et seg.).

Section 2. The San Francisco Park Code is hereby amended by amending Section 12.32, to read as follows:

## SEC. 12.32. RESIDENT GOLF CARDS.

- An annual fee of \$40.00 \$45.00 shall be charged for San Francisco Resident Golf Cards, entitling the holder to discounts on the golf courses under the jurisdiction of the Recreation and Park Department. Cards shall be available to San Francisco residents only.
- (b) An annual fee of \$30 shall be charged to Pacifica residents for a Pacifica Resident Card for use at Sharp Park for Fiscal Year 2007-2008. The fee will increase to \$45.00 in Fiscal Year 2008-2009.
- A fee of \$25.00 shall be charged for replacement of San Francisco and Pacifica Resident Golf Cards.
