
Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Peter Firestone v. Xuong Lu, et al., San Francisco Superior Court, Case No. CGC-14-542359 by the payment of \$50,000 and co-defendants to pay \$60,000. The lawsuit involves alleged personal injury from vehicle collision.

Section 2. The above-named action was filed in San Francisco Superior Court on October 24, 2014, and the following parties were named in the lawsuit: Plaintiff: Peter Firestone; Defendants: Xuong Lu, Cuong Vinh Tu, Kieu Thai, Carolina Michel, Khalid Khan, S. 
