17 she is a current member of an assessment appeals board, for the unexpired portion of a
18 three-year term ending September ³~~7~~, 2012.

19 Lawrence Lee, succeeding himself, term expired, seat 5, must meet the eligibility
20 criteria set forth in Section 1624.05 of the California Revenue and Taxation Code as follows:
