With honors, I graduated from the University of San Francisco (USF) with a Bachelor of Science in Kinesiology and a Health Studies minor in 2018. At age 46, I now own a gym in the South of Market neighborhood, called Route Fitness and am a graduate student at San Francisco State University (SFSU) in the Kinesiology program, set to graduate this May 2024 Summa Cum Laude. My coursework focuses on health promotion, social justice, disease prevention and health equity. I have received service awards and I have published work in a medical journal. I have been told my work has saved lives. To address facilitators and barriers to good health, I meet with the community in various neighbors in the city. Many members of the community have expressed some suggestions for the park and recreation department. I am ready to represent the community.
