Be it ordained by the People of the City and County of San Francisco:

Section 1.

Chapter 2 of the San Francisco Administrative Code is hereby amended by adding  
Section 2.7, to read as follows:

**SEC. 2.7. Supervisory Nominations to Boards and Commissions.**

Notwithstanding any provision to the contrary in any City ordinance, except where the Charter or pre-emptive state or federal law requires otherwise, whenever a City ordinance establishing a board, commission or similar body allows an individual supervisor to nominate or appoint a person for service on the body, whether or not subject to approval by the Board, that person shall be qualified for service once the supervisor has submitted a written nomination accompanied by an application completed by the nominee to the clerk of the Rules Committee. Upon receipt of the written nomination and the application, the clerk of the Rules Committee shall issue a letter of qualification for service to the nominee, memorializing the

1 nominee's appointment and specifying the term during which the appointee shall serve. The  
2 appointment shall become effective at the commencement of the day immediately following  
3 the date of the clerk's letter.




