3 **Motion appointing Jada Curry and Jennifer Salerno, terms ending July 1, 2022, and**  
4 **Julie Roberts-Phung, term ending July 1, 2023, to the Children, Youth and Their**  
5 **Families Oversight and Advisory Committee.**

7 MOVED, That the Board of Supervisors of the City and County of San Francisco does  
8 hereby appoint the hereinafter designated person to serve as a member of the Children,  
9 Youth and Their Families Oversight and Advisory Committee, pursuant to the provisions of  
10 Administrative Code, Sections 2A.233-2A.234, and Charter, Section 16.108-1, for the term  
11 specified:

12 Jada Curry, seat 7, succeeding themselves, term expired, shall be a person who is a  
13 disconnected transitional-aged youth, as that term is used in Charter, Section 16.108, 18  
14 through 24 years of age at the time of appointment, and who is familiar with the issues and  
15 challenges faced by disconnected transitional-aged youth and with services, programs, and  
16 systems for them, for a two-year term ending July 1, 2022;

17 Jennifer Salerno, seat 11, succeeding Joanna Powell (resigned), term expired, shall be  
18 a person who has demonstrated commitment to improving access to and quality of services  
19 for children, youth and families, for a two-year term ending July 1, 2022;

20 Julie Roberts-Phung, seat 8, succeeding Winnie Chen, term expired, shall be a person  
21 who is a parent or guardian of a child, which child is enrolled in kindergarten through 8th  
22 grade at the time of the member's appointment for the term. This member shall be from a  
23 low-income community or have expertise or substantial experience working to promote the  
24 interests of communities of color and shall have demonstrated a commitment to improving  
25

1 access and quality of services for children, youth and families, for a two-year term ending July  
2 1, 2023.
