9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Ibrahim Nimer Shiheiber v. Officer  
12 Brent Hernandez #307, United States District Court-Northern District, Case No. 21-cv-00609  
13 JCS by the payment of \$50,000. The lawsuit involves alleged civil rights violation.

14 Section 2. The above-named action was filed in United States District Court-Northern  
15 District on April 30, 2021, and the following parties were named in the lawsuit: plaintiff Ibrahim  
16 Nimer Shiheiber; defendant Officer Brent Hernandez #307.
