3 **Ordinance authorizing settlement of the lawsuit filed by Tatiana Umnov and Anatoly**  
4 **Umnov against the City and County of San Francisco for \$450,000; the lawsuit was filed**  
5 **on September 20, 2021, in San Francisco Superior Court, Case No. CGC-21-595303;**  
6 **entitled Tatiana Umnov, Anatoly Umnov v. City and County of San Francisco, et al.; the**  
7 **lawsuit involves alleged personal injury on a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Tatiana Umnov, Anatoly Umnov v. City  
12 and County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-  
13 595303 by the payment of \$450,000. The lawsuit involves alleged personal injury on a City  
14 sidewalk.

15 Section 2. The above-named action was filed in San Francisco Superior Court on  
16 September 20, 2021, and the following parties were named in the lawsuit: plaintiffs Tatiana  
17 Umnov and Anatoly Umnov; defendant City and County of San Francisco.
