4 **Capital Improvement Promotion and Event Fund from The Boeing Company, Hensel**  
5 **Phelps Construction Co., and United Airlines, Inc., pursuant to Administrative Code,**

8 WHEREAS, By Ordinance No. 267-13, adopted by the Board of Supervisors on  
9 November 19, 2013, established the Airport Capital Improvement Promotion and Event Fund;  
10 and

11 WHEREAS, The Ordinance requires Board of Supervisors' approval by Resolution of  
12 all donations to the Fund of \$100,000 or greater; and

13 WHEREAS, On November 12, 2013, by Resolution No. 13-0241, the Airport  
14 Commission acknowledged anticipated donations of \$100,000 or greater from The Boeing  
15 Company, Hensel Phelps Construction Co., and United Airlines, Inc., totaling \$400,000 for  
16 partial use on events and promotions relating to the opening of the Airport's new Terminal 3,  
17 Boarding Area E project; and

18 WHEREAS, The Airport Commission directed staff to forward anticipated donations to  
19 the Board of Supervisors for approval by Resolution; now, therefore, be it

20 RESOLVED, That this Board of Supervisors approves by Resolution the donations of  
21 \$100,000 or greater from The Boeing Company, Hensel Phelps Construction Co., and United  
22 Airlines, Inc., totaling \$400,000 to the Airport Capital Improvement Promotion and Event Fund.

1 [Administrative Code - Airport Capital Improvement Promotion and Event Fund]

3 **Ordinance amending San Francisco Administrative Code, Section 10.100-18, to**  
4 **establish a special fund to receive donations and authorize expenditures for the**  
5 **purpose of holding events to promote the opening of major capital improvement**  
6 **projects at the San Francisco International Airport; and deleting obsolete provisions.**

11 Be it ordained by the People of the City and County:

12  
13 Section 1. The San Francisco Administrative Code is hereby amended by amending  
14 Section 10.100-18, to read as follows:

15 SEC. 10.100-18. AIRPORT ~~TERMINAL-2~~ CAPITAL IMPROVEMENT PROMOTION AND  
16 EVENT FUND.

17 (a) Establishment of the Airport ~~Terminal-2~~ Capital Improvement Promotion and Event  
18 Fund. Airport ~~Terminal-2~~ Capital Improvement Promotion and Event Fund is hereby  
19 established-as a category six fund for the purpose of receiving all donations of money,  
20 property and personal services which may be offered to the City and County of San Francisco  
21 through the Airport for the uses described in subsection (b).

22 (b) Use of the Airport ~~Terminal-2~~ Capital Improvement Promotion and Event Fund.  
23 Money, property and personal services comprising the Fund shall be used and expended for  
24 such purposes as will be determined in the sole discretion of the Airport Commission to assist  
25

1 in promotional events and community outreach activities associated with the opening of ~~the~~  
2 ~~newly renovated Terminal 2~~ capital improvements of the San Francisco International Airport.  
3 The Fund shall have a separate accounting for each capital improvement project as  
4 determined by the Airport Commission.

5 (c) Exceptions to Fund Category. Money, property and personal services comprising  
6 the Airport ~~Terminal 2~~ Capital Improvement Promotion and Event Fund shall be expended ~~for~~  
7 to promote the capital improvement project for which the donation was made, such purposes  
8 as will be determined in ~~at~~ the sole discretion of the Airport Commission. Any unexpended  
9 balances remaining in the Fund when it expires on December 31, 2014~~23~~ shall be deposited  
10 in the City's General Fund.

11 (d) Administration of Fund. The Airport Director shall submit to the Board of  
12 Supervisors and the Budget Analyst on an ~~bi-monthly~~ quarterly ~~annual~~ basis written reports of  
13 revenues to and expenditures from the Airport ~~Terminal 2~~ Capital Improvement Promotion and  
14 Event Fund during the ~~bi-monthly~~ quarterly ~~annual~~ period covered by the report. This fund  
15 shall expire on December 31, 2014~~23~~. Acceptance of donations of \$100,000 or greater shall  
16 require Board of Supervisors approval by resolution.

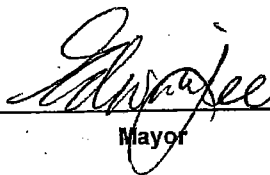

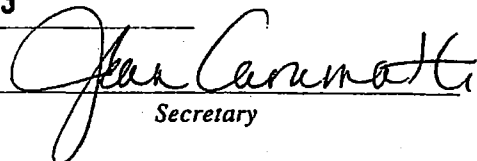
**APPROVE THE ACCEPTANCE AND EXPENDITURE OF DONATIONS OF \$100,000 OR GREATER TO THE AIRPORT CAPITAL IMPROVEMENT PROMOTION AND EVENT FUND FROM THE BOEING COMPANY, HENSEL PHELPS CONSTRUCTION CO. AND UNITED AIRLINES, AND DIRECT THE COMMISSION SECRETARY TO SEEK APPROVAL FROM THE BOARD OF SUPERVISORS PURSUANT TO ADMINISTRATIVE CODE SECTION 10.100-18 WHICH ESTABLISHED THE AIRPORT CAPITAL IMPROVEMENT PROMOTION AND EVENT FUND**

- WHEREAS, Airport Commission Resolution 13-0167 recommended that the Board of Supervisors adopt an ordinance establishing a special fund to receive donations to offset the costs of Airport special events related to the opening of major Capital Improvement Plan projects, and authorizing the Airport Commission to make expenditures from the fund for that purpose; and
- WHEREAS, the proposed Airport Capital Improvement Promotion and Event Fund ordinance (File No. 13-0799) was submitted to the Board of Supervisors and passed by the Finance Committee on October 30, 2013; and
- WHEREAS, the ordinance establishing the Airport Capital Improvement Promotion and Event Fund requires two readings before the full Board of Supervisors which are expected to occur on November 5, 2013 and November 19, 2013; and
- WHEREAS, the proposed ordinance requires Board of Supervisors' approval by resolution of all donations to the Fund of \$100,000 or greater; and
- WHEREAS, the Airport anticipates donations of \$100,000 or greater from The Boeing Company, Hensel Phelps Construction Co. and United Airlines, Inc.; now, therefore, be it
- RESOLVED, that this Commission hereby directs the Commission Secretary to seek approval from the Board of Supervisors to accept and expend these donations of \$100,000 or greater in conformance with the proposed amended Administrative Code Section 10.100-18, establishing the Airport Capital Improvement Promotion and Event Fund.
