19 WHEREAS, MUNI employees are also valuable members of our community,  
20 participating in the San Francisco Combined Charities Campaign and many other charitable  
21 and civic organizations that contribute tremendously to the fabric of our community; and,

22 WHEREAS, The men and women of the San Francisco Municipal Railway are  
23 working to make MUNI the transportation provider of choice, as well as the employer of  
24 choice in San Francisco; now, therefore, be it
