3 **Ordinance authorizing settlement of the lawsuit filed by Dora Delfi Mejia Jacobo**
4 **against the City and County of San Francisco for \$50,000; the lawsuit was filed on**
5 **May 19, 2015, in San Francisco Superior Court, Case No. CGC-15-545823; entitled Dora**
6 **Delfi Mejia Jacobo v. Greg Suhr in his official capacity, et al.; the lawsuit involves**
7 **alleged civil rights violations.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Dora Delfi Mejia Jacobo v. Greg Suhr
12 in his official capacity, et al., San Francisco Superior Court, Case No. CGC-15-545823 by the
13 payment of \$50,000. The lawsuit involves alleged civil rights violations.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 May 19, 2015, and the following parties were named in the lawsuit: Dora Delfi Mejia Jacobo,
16 Plaintiff; City and County of San Francisco, Chief Greg Suhr, in his official capacity, San
17 Francisco Police Department, Sergeant Donald Anderson, and Officers Nicholas M. Buckley
18 and Duncan Duffin, Defendants.




