3 **Ordinance amending the San Francisco Traffic Code by repealing expired Section**  
4 **33.3.1 establishing heavy truck loading zones, and making a conforming change to**  
5 **Section 132 to eliminate the penalty for violating Section 33.3.1.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Traffic Code is hereby amended by repealing Section  
11 33.3.1, to read as follows:

12 ~~SEC. 33.3.1. HEAVY TRUCK LOADING ZONES.~~

13 ~~When the Director of Parking and Traffic shall determine that the establishment of a heavy~~  
14 ~~truck loading zone on streets in the City and County of San Francisco is reasonably necessary or~~  
15 ~~desirable for the regulation of traffic, the Director is hereby authorized to designate such zones on any~~  
16 ~~portion of a street wherein, between the hours designated by the Director, stopping, standing or~~  
17 ~~parking shall be limited to heavy trucks for the purpose of loading or unloading freight for a maximum~~  
18 ~~period as designated by the Director. The zones shall be posted with signs giving notice of the stopping,~~  
19 ~~standing and parking restrictions effective in the zone. In parking meter areas, the zones will have~~  
20 ~~parking meters permitting a maximum parking time as designated by the Director. The denomination of~~  
21 ~~the coin or coins that shall be deposited in these parking meters, the parking time allowed following~~  
22 ~~deposit of such coins or use of a debit card, and the hours during which such deposits are required~~  
23 ~~shall be the same as those set for all other parking meters in the same parking meter area or areas.~~

1           ~~Where there are multiple parking meters in a heavy truck loading zone and the length of the~~  
2 ~~heavy truck necessitates that it occupy more than one parking meter stall, the deposit of coins or the~~  
3 ~~use of a debit card will be required at only one of the parking meters.~~

4           ~~No person shall stop, stand or park any vehicle, whether attended or unattended, in a heavy~~  
5 ~~truck loading zone established pursuant to the provisions of this Section between the hours designated~~  
6 ~~by the Director of Parking and Traffic on any day, provided that heavy trucks may stop, stand or park~~  
7 ~~for the purpose of loading or unloading freight for a period not in excess the maximum period~~  
8 ~~designated by the Director. Any vehicle parked or stopped in violation of this Section shall be deemed~~  
9 ~~to be left standing on a street in an unusual position and obstructing the normal movement of traffic~~  
10 ~~thereof. Such vehicle shall be subject to removal under the provisions of Section 22651(b) of the~~  
11 ~~Vehicle Code of the State of California.~~

12           ~~The term "heavy truck" as used in this Section shall mean a motor vehicle designed, used, or~~  
13 ~~maintained primarily for the transportation of property and having a gross vehicle weight exceeding~~  
14 ~~20,000 pounds verified by a permit issued by the Director and affixed to be left rear bumper of the~~  
15 ~~vehicle. The Department of Parking and Traffic is authorized to collect a fee to recover the costs for the~~  
16 ~~issuance of this permit.~~

17           ~~This Section shall be implemented on a trial basis for a period of one year.~~

18           Section 2. The San Francisco Traffic Code is hereby amended by amending Section  
19 132, to read as follows:

20           **SEC. 132. PENALTY SCHEDULE.**

21           Pursuant to California Vehicle Code Section 40203.5, violation of any of the following  
22 subsections of the San Francisco Traffic Code (TC), Police Code (PC) or the California  
23 Vehicle Code (VC) shall be punishable by the fines set forth below.
