15 accountant (PA); licensed real estate broker; attorney; or a property appraiser accredited by a
16 nationally recognized professional organization, or property appraiser certified by the Office of
17 Real Estate Appraisers; or he or she is a current member of an assessment appeals board,
18 for the unexpired portion of a three-year term ending September 4, 2006.

19 Joseph Tham, succeeding himself, term expired, seat 8 (ALTERNATE/HEARING
20 OFFICER), must meet the eligibility criteria set forth in Section 1624.05 of the California
21 Revenue and Taxation Code: Must have a minimum of five years professional experience in
22 the State of California as one of the following: certified public accountant (CPA) or public
23 accountant (PA); licensed real estate broker; attorney; or a property appraiser accredited by a
24 nationally recognized professional organization, or property appraiser certified by the Office of

1 Real Estate Appraisers; or he or she is a current member of an assessment appeals board,
2 for the unexpired portion of a three-year term ending September 1, 2008.


