My name is Pamela Tate and I am the Co-Executive Director of Black Women Revolt, which is a Dream Keeper Initiative Program. We are honored to be recipients of DKI Funds and we are grateful for their ongoing support in our efforts to eradicate domestic violence from the lowest percentage of residents in San Francisco - the Black Community.

We have grown from a donated office with a volunteer staff to a paid staff of six with six interns (4 in college and 2 in high school), which is housed in the Bayview Hunters Point.

We have made in impact in District 10 and in spaces all around the City. We are supporting employees whose employees are experiencing domestic abuse. We are teaching youth and adults about healthy relationships. We are helping to repair families and helping them learn habits that will keep their families safe. None of this would be possible without Dream Keepers Initiative.

On Monday, April 16, 2024, which was Tax Day, we were informed that we would not be receiving funds from DCYF for the next five (5) years. That was truly disheartening! We are fortunate that we are receiving DKI finds, but I know that we would cease to exist without their expertise and support. Please continue to support the Dream Keepers Initiative! They are vital to the survival of Blacks in San Francisco.
