5 LITERACY CHALLENGE GRANT FROM THE CALIFORNIA DEPARTMENT OF EDUCATION

15 with the Unified School District using innovative programs to
16 integrate technology available in the library into the normal
17 routines and assignments of teachers, school librarians and students,
18 and provide links to City Government and other Community information;

20 WHEREAS, The Public seeks to provide free public access to the
21 tools of information literacy to all members of the community; and,

22 WHEREAS, The Public Library proposes to maximize use of
23 available grant funds on program expenditures by not including
24 indirect costs in the grant budget; now, therefore, be it


