10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The San Francisco Administrative Code is hereby amended by amending  
12 Section 7.4, to read as follows:

13 **SEC. 7.4. DISASTER COUNCIL - POWERS AND DUTIES.**

14 It shall be the duty of the City and County Disaster Council and it is hereby  
15 empowered:

16 (a) To develop a plan for meeting any emergency, such plan to provide for the  
17 effective mobilization of all the resources of the community, both public and private; and to  
18 prepare and recommend for consideration and adoption by the Board of Supervisors such  
19 ordinances and resolutions and rules and regulations as are necessary to implement the  
20 emergency plan;


21 (b) To develop and recommend for consideration and adoption by the Board of  
22 Supervisors mutual- aid plans and agreements and such ordinances and resolutions and rules  
23 and regulations as are necessary to implement such plans and agreements; and

24 (c) To meet upon call of the chair, but no less often than on a quarterly basis.

25 By enacting this Chapter, the City and County hereby agrees to follow the rules and  
regulations established by the California Emergency Council under the provisions of the  
California Emergency Services Act, Chapter 7 of Division 1 of Title 2 of the Government Code




