1 [Preparation of findings related to the exemption determination for the 2750 Vallejo Street  
2 project.]

3  
4 **Motion directing the Clerk of the Board to prepare findings related to the appeal of the**  
5 **exemption determination by the Planning Department that the project at 2750 Vallejo**  
6 **Street is exempt from environmental review.**

7  
8 WHEREAS, On May 6, 2009, the Planning Department determined that a proposal to  
9 alter the façade and construct rear and side horizontal additions to an existing three-story,  
10 single-family residence in an RH-1 (D) and a 40-X Height and Bulk District, located at 2750  
11 Vallejo Street (the "Project") was exempt/excluded from environmental review under the  
12 California Environmental Quality Act ("CEQA"), the CEQA Guidelines and San Francisco  
13 Administrative Code Chapter 31 (the "exemption determination"). A copy of said document is  
14 on file with the Clerk of the Board of Supervisors in File No. 091309, and is incorporated by  
15 reference in this motion; and,

16 WHEREAS, On July 23, 2009, the Planning Commission conducted a discretionary  
17 review hearing on the Project and approved the Project; and,

18 WHEREAS, By letter to the Clerk of the Board of Supervisors dated November 5, 2009,  
19 Robert A. Byrum and Dona S. Byrum ("Appellants") filed an appeal of the exemption  
20 determination to the Board of Supervisors, which the Clerk of the Board of Supervisors  
21 received on or around November 6, 2009; and,

22 WHEREAS, On December 15, 2009, this Board held a duly noticed public hearing to  
23 consider the appeal of the exemption determination filed by Appellant; and,

24 WHEREAS, This Board has reviewed and considered the exemption determination, the  
25 appeal letter, the responses to concerns document that the Planning Department prepared,

1 the other written records before the Board of supervisors, and heard public testimony in  
2 support of and opposed to the exemption determination appeal; and,

3 WHEREAS, The exemption determination files and all correspondence and other  
4 documents have been made available for review by this Board and the public. These files are  
5 available for public review by appointment at the Planning Department offices at 1650 Mission  
6 Street, and are part of the record before this Board by reference in this motion; now, therefore,  
7 be it

8 MOVED, That this Board of Supervisors directs the Clerk of the Board to prepare the  
9 findings specifying the basis for its decision on the appeal of the exemption determination  
10 issued by the Planning Department for the Project.
