3 **Resolution recognizing April 6, 2026, as the 100th Anniversary of United Airlines and**
4 **its central role in San Francisco's economy and global connectivity.**

6 WHEREAS, United Airlines, founded in 1926, has grown into a global aviation leader
7 connecting San Francisco to destinations across the world; and

8 WHEREAS, San Francisco International Airport (SFO) serves as United Airlines'
9 primary West Coast hub and international gateway, with United operating approximately 45
10 percent of all passenger traffic; and

11 WHEREAS, United Airlines' hub at SFO is a cornerstone of the regional economy,
12 supporting an estimated \$24 billion in annual economic activity and more than 115,000 direct
13 and indirect jobs across the Bay Area; and

14 WHEREAS, United's operations are critical to San Francisco's tourism, convention,
15 and business sectors, facilitating billions in visitor spending, supporting tax revenues, and
16 enabling global trade, investment, and innovation; and

17 WHEREAS, United Airlines employs thousands of union-represented workers at SFO;
18 and

19 WHEREAS, During the COVID-19 pandemic, United Airlines maintained essential air
20 service and cargo operations, supporting the City's resilience and economic recovery; and

21 WHEREAS, United Airlines' continued investment in SFO, including international
22 service, fleet modernization, and sustainable aviation initiatives, is vital to San Francisco's
23 long-term economic competitiveness as a global city; now, therefore, be it
