DETERMINING THAT THE ISSUANCE OF A TYPE 42 ON-SALE BEER AND WINE-PUBLIC PREMISES ALCOHOLIC BEVERAGE CONTROL LICENSE TO MOLOUK AND MINA FARAJI FOR CALIFORNIA WINE HARVEST, LOCATED AT 2800 LEAVENWORTH STREET, WILL SERVE THE CONVENIENCE OF THE PEOPLE OF THE CITY AND COUNTY OF SAN FRANCISCO, IN ACCORDANCE WITH SECTION 23958.4 OF THE CALIFORNIA BUSINESS AND PROFESSIONS CODE; WITH CONDITIONS.

WHEREAS, Molouk and Mina Faraji are seeking issuance of a Type 42 on-sale beer and wine-public premises alcoholic beverage control license for California Wine Harvest, located at 2800 Leavenworth Street; and,

WHEREAS, The City Planning Department has verified that the area is properly zoned; and,

WHEREAS, The Police Department recommends that the liquor license application be approved with conditions; now, therefore, be it

RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code, the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that the issuance of a Type 42 on-sale beer and wine-public premises alcoholic beverage control license, to Molouk and Mina Faraji for California Wine Harvest, located at 2800 Leavenworth will serve the convenience of the people of the City and County of San Francisco.

Conditions: (1) The applicants shall have no more than a small wine tasting area within their shop; (2) The wine tasting area shall be readily identified within the shop. This shall be accomplished by permanently affixed barriers that surround the tasting area. The opening, door or space that leads to the area shall have a sign readily visible stating "No Minors, Must be 21 Years of Age to Enter"; (3) There shall be no entertainment of any type allowed on the premises; (4) The license is issued with the understanding that this applicant, or any future applicant shall never operate this premise as a Beer and Wine Public Premise; (5) If a problem occurs getting approval ;by ABC, this Committee shall revisit these issues.


