 4 **12.08, to increase the parking fees at the Kezar Parking lot, and making environmental**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Findings.

11 (a) The Planning Department has determined that the actions contemplated in this
 12 Ordinance are in compliance with the California Environmental Quality Act (California Public
 13 Resources Code section 21000 et seq.). Said determination is on file with the Clerk of the
 14 Board of Supervisors in File No. _____ and is incorporated herein by reference.

15 Section 2. The San Francisco Park Code is hereby amended by amending Section
 16 12.08, to read as follows:

17 **SEC. 12.08. PARKING FEES ON RECREATION AND PARK PROPERTY.**

18 (a) The following fees shall be charged for parking at the Kezar Parking Lot.

19 **(1) Hourly Parking Rates.**

20 0—1 hour	\$2.50
21 1—2 hours	\$5.00
22 2—3 hours	\$7.00
23 3—4 hours	\$10.00
24 4—5 hours	\$12.00

1	5—6 hours	\$14.00
2	6—7 hours	\$16.00
3	7—24 hours	\$18.00
4	Special Event Parking	\$10.00

7 **(2) Monthly Parking Rates.**

8	Resident	\$140.00 <u>160.00</u>
9	Seniors	\$60.00
10	Commercial (Monday—Friday)	\$165.00 <u>185.00</u>

12 **(3) Other Rates.**

13	Lost Ticket Fee	\$18.00
14	Validated Ticket Books (100 stickers)	\$150.00

16 **(b) Candlestick Parking Lots.**

17 (1) The daily fee for vehicles and trailers parking in the television compound
18 during football season and for televised soccer events shall be \$1,000.00 per day.

19 (2) The fee for automobile and tire manufacturer and/or dealer shows shall be
20 \$2,500.00 per day for set-up and breakdown and \$5,000.00 per day for the show.

21 (3) The fee for car clubs shall be \$2,500.00 per day plus an additional
22 \$1,250.00 for use of the entire lot which includes the RV section.

23 (4) The fee for photography shoots shall be \$2,500.00 per day for use of the
24 parking lot, and \$4,000.00 per day for use of the stadium.

1 (c) **Other Recreation and Park Property.** The daily fee for parking on other
2 Recreation and Park property, except for garages and specifically designated parking lots
3 subject to separate fee-setting procedures, shall be from \$0.50 (fifty cents) to \$1.00 per hour,
4 the amount to be determined by the Recreation and Park Commission after considering the
5 costs of parking in the areas adjacent to the park property.
