2 **URGING GOVERNOR GRAY DAVIS TO MAINTAIN CURRENT LEVELS OF STATE**
3 **FUNDING FOR AIDS-HIV AND AID-HIVS RELATED SERVICES AND PROGRAMS .**

4 WHEREAS, Governor Gray Davis released the 1999-2000 budget of the state of
5 California; and

6 WHEREAS, The 1999-2000 budget will allocate full funding for health programs, \$90
7 million to raise the monthly grant for a family of three from \$611 to \$624, and a 2.5 percent
8 cost of living increase for state employees; and

9 WHEREAS, In addition, the new budget will also allocate increases for low-cost health
10 and dental coverage to low and moderate income children, several million dollars for housing
11 for the homeless, disabled, and welfare recipients, \$1 million to fund supportive housing and
12 services for people with mental disability, \$5 million for housing for CalWORKS families
13 moving from welfare to work, \$2 million to fund farm-worker assistance program, \$20 million to
14 restore Lake Tahoe, and \$2.6 million to the Department of Justice to improve civil rights,
15 environmental and consumer protection, and enforce elder abuse laws; and

16 WHEREAS, However, only \$235.5 million was allocated to AIDS funding which is \$4.1
17 million reduction from current levels; and

18 WHEREAS, During the past five years, there has been a 200 percent increase in the
19 number of AIDS-HIV cases, affecting primarily youth, minorities, and women; now, therefore,
20 be it

21 **RESOLVED**, That the Board of Supervisors of the City and County of San Francisco
22 urges Governor Gray Davis to maintain current levels of funding for AIDS-HIV and AIDS-HIV
23 related services and programs.




