10 Be it ordained by the People of the City and County of San Francisco:


11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
12 authorizes the City Attorney to settle the action entitled Tureko Straughter, individually and as  
13 the guardian for minor K.R.; and K.R., a minor, by and through his guardian Tureko  
14 Straughter, United States District Court, Case No. 18-cv-03651, by the payment of \$160,000.  
15 The lawsuit involves alleged civil rights violations.

16 Section 2. The above-named action was filed in United States District Court on  
17 August 22, 2018, and the following parties were named in the lawsuit: Plaintiffs: Tureko  
18 Straughter, and K.R., a minor; Defendants: City and County of San Francisco, Allen Nance,
