Contract Summary

- PeopleSoft Contract ID: 1000032407
- Covered services: Unarmed security guard services for the San Francisco Human Services Agency (HSA).
- Awarded contractor: Good Guard Security Inc. ("Good Guard"), selected through a Request for Proposals ("RFP", Sourcing Event ID 0000008334) issued by the Office of Contract Administration (OCA) in June 2023.
- Initial contract not-to-exceed amount and duration: \$33,760,000, commencing on July 1, 2024 and ending on June 30, 2029, with the option to extend the term for two additional years through June 30, 2031.

SF Human Services Agency (HSA)

- HSA delivers essential services that support individuals and families in San Francisco, including:
 - CalFresh food stamps, meals, and groceries
 - Financial support for individuals, families, renters
 - Insurance programs for the elderly and adults with disabilities
 - JobsNOW! job placement
 - Free/low-cost child care through partner agencies
 - Short-term and long-term housing assistance
 - Public benefits and legal assistance for immigrants
 - Child welfare and family support services
 - Foster care, adoption, and conservatorship

Prop J Authorization

- Each year, the Board of Supervisors authorizes HSA to contract for private security guard services for its various facilities pursuant to Charter, Section 10.104-15 ("Prop J").
- HSA's most recent Prop J approval was obtained under Board Resolution No. 369-23 passed on July 18, 2023.
- Based on its continuing annual Prop J approval from the Board of Supervisors, HSA currently utilizes private security guards for its 13 locations. (See Table 1 for a list of all HSA locations)

Sourcing Event 0000008334

- HSA currently procures private security guard services from Allied Universal under Contract 1000010873.
- Contract 1000010873 with Allied Universal commenced on July 1, 2018 and will expire on June 30, 2024. This contract cannot be further extended.
- In June 2023, OCA issued Sourcing Event 0000008334 for the purpose of awarding a new contract for procuring security guard services for HSA.

Sourcing Event 0000008334 Results

- In response to Sourcing Event 0000008334, OCA received 17 proposals. Two firms withdrew their proposals and three were deemed non-responsive.
- The remaining 12 proposals were evaluated by a panel of four City employees from HSA's Human Resources, Investigations, and Workforce Development divisions, as well as the Department of Homelessness and Supportive Housing.
- On March 5, 2024, OCA issued a Notice of Intent to Award deeming Good Guard as the highest ranked proposer for Sourcing Event 0000008334. (See Table 2 for a summary of each proposer's ranking)

Proposed Contract Pricing Structure

- The RFP evaluated proposers' pricing based on the lowest percentage mark up over the fully-loaded Prevailing Wage Rate for Security Guards published under SF Labor and Employment Code Article 102.11.
- For 2024, the fully-loaded Prevailing Wage rate for security guard services ranges from \$20/HR to \$32.88/HR for straight time, \$30/HR to \$42.88/HR for overtime, and \$40/HR to \$52.88/HR for double overtime.
- Good Guard's percentage mark up over the fully-loaded Prevailing Wage Rate for Security Guards ranges from 30.84% to 52.43%. (See Table 3 for each markup based on shift type)

Contract Budget and Funding

- HSA has budgeted \$34,300,000 for Contract ID 1000032407 with Good Guard.
- HSA's budgeted amount will draw from the following funding sources:
 - San Francisco County general fund: 75%
 - State of California general fund: 12%
 - Federal programs administered by the Department of Health and Human Services and Department of Agriculture Food and Nutrition Service: 13%

Proposed NTE Calculations

- Between July 1, 2018 and June 30, 2024, HSA
 encumbered an average of \$349,482 per year for private security guard services.
- Based on this annual amount, OCA estimates that the proposed 7 year contract with Good Guard will have a not to exceed amount ("NTE") of \$33,760,000.
- As per the solicitation and contract terms, this amount can be adjusted should actual spend not align with the estimated NTE.

Conclusion

- HSA delivers essential services that support and protect people, families, and communities in San Francisco.
- Contract 1000032407 with Good Guard will provide unarmed security guard services for all HSA sites, thereby ensuring the safety of its employees and the members of the public who visit those locations each day.
- OCA respectfully requests that the Board approve this contract to allow HSA to provide uninterrupted security guard services at each of its location.
