4 **Resolution authorizing the Department of Public Health, San Francisco General**
5 **Hospital to accept a gift of a mobile mammography facility vehicle and associated**
6 **equipment, valued at \$432,716, donated by the University of California, San Francisco**
7 **for mobile mammography services to indigent and under-served women in San**
8 **Francisco.**

10 WHEREAS, the University of California, San Francisco (UCSF) is a not-for-profit public
11 medical academic institution engaged in the provision of health-care services to
12 disadvantaged residents of San Francisco, among other populations; and,

13 WHEREAS, San Francisco General Hospital (SFGH) is a public hospital that provides
14 health-care services to the indigent and under-served residents of San Francisco; and,

15 WHEREAS, the mobile mammography facility vehicle (Mammovan), including the
16 equipment, software, peripherals, and manuals was purchased by UCSF for the purposes of
17 providing mammography services to indigent and under-served women in San Francisco;
18 and,

19 WHEREAS, SFGH has committed to continue providing mobile mammography
20 services to indigent and under-served women in San Francisco; and

21 WHEREAS, SFGH has received grant funding from the Avon Foundation for the
22 continuation of the mobile mammography project initiated by UCSF; and

23 WHEREAS, UCSF has agreed to arrange for smog testing of the Mammovan and all
24 other activities required to transfer title to the Mammovan to SFGH; and

1 WHEREAS, SFGH agrees, as a condition of the transfer as set forth in the attached
2 agreement, that UCSF and the Regents of the University of California assume no
3 responsibilities and makes no guarantees for the performance of the equipment, that the
4 Mammovan is being transferred on an "As Is" basis without warranties as to fitness for use or
5 merchantability, and that neither UCSF nor the Regents of the University of California will be
6 liable for any claims arising out of the possession or use of the Mammovan and associated
7 equipment; and

8 WHEREAS, the Department wishes to obtain approval from the Health Commission
9 and the Board of Supervisors to accept the gift of the Mammovan and the associated
10 equipment; and now, therefore, be it

11 RESOLVED, That the Department of Public Health, San Francisco General Hospital is
12 hereby authorized to accept a gift of the Mammovan, with a value of \$432,716 from UCSF for
13 the provision of mobile mammography services to indigent and under-served women in San
14 Francisco.
