3 **Ordinance authorizing settlement of the lawsuit filed by Madison Cullinane against the**
4 **City and County of San Francisco for \$40,000; the lawsuit was filed on January 27,**
5 **2022, in San Francisco Superior Court, Case No. CGC-22-597860; entitled Madison**
6 **Cullinane v. City and County of San Francisco, et al.; the lawsuit involves alleged**
7 **personal injury from a motor vehicle accident.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Madison Cullinane v. City and County
12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-22-597860 by the
13 payment of \$40,000. The lawsuit involves alleged personal injury from a motor vehicle
14 accident.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 January 27, 2022, and the following parties were named in the lawsuit: plaintiff Madison
17 Cullinane; defendants City and County of San Francisco and Kenneth Ray Massingale.
