

1 [Certification to Accompany Application for State Grant for construction of an Ingleside Branch  
2 Library.]

3 **Resolution certifying project budget, local funding, supplemental funding and public**  
4 **library operations pursuant to the California Reading and Literacy Improvement and**  
5 **Public Library Construction and Renovation Bond Act of 2000.**

7 WHEREAS, The voters of the State of California in March 2000 passed Proposition 14,  
8 "The California Reading and Literacy Improvement and Public Library Construction and  
9 renovation Bond Act of 2000" ("Bond Act") that provides state matching grants, on a  
10 competitive basis, for qualifying library construction and remodeling projects; and  
11

12 WHEREAS, The voters of the City and County of San Francisco in November 2000  
13 passed Proposition A, "Branch Library Facilities Improvement Bonds, 2000" that authorized  
14 the City to issue general obligation bonds to acquire, remodel, or construct branch libraries  
15 and additional library facilities; and

16 WHEREAS, The City and County of San Francisco seeks a state matching grant under  
17 the Bond Act to construct a San Francisco Public Library Ingleside Branch Library; and

18 WHEREAS, On November 20, 2003 the Library Commission passed a resolution  
19 approving the Proposition 14 grant application for the new Ingleside Branch Library; and

20 WHEREAS, A copy of the City's proposed Bond Act grant application, including  
21 application form and supporting documentation is on file with the Clerk of the Board of  
22 Supervisors in File No. , which is hereby declared to be a part of this resolution as if set  
23 forth fully herein; and,

24 WHEREAS, The Board of Supervisors is required under section 20440, Title 5; of the  
25 California Code of Regulations to certify the Bond Act grant application; now, therefore, be it

1 RESOLVED, That Board of Supervisors hereby certifies the City's Bond Act grant  
2 application, and commits as follows

3 (1) to provide the local matching funds in the amount of \$ 2,020,277;

4 (2) to provide supplemental funds necessary to complete the project in the  
5 amount of \$ 216,230;

6 (3) to make the local matching and supplemental funds available when they are  
7 needed to meet cash flow requirements for the project;

8 (4) to certify the good faith development of the project budget as contained in  
9 the Library project budget section of the application form;

10 (5) to certify the accuracy and truthfulness of all information submitted in the  
11 Application Form and the required supporting documents;

12 (6) to operate the completed new Ingleside Branch Library and provide public  
13 library direct service; and

14 (7) to dedicate the Ingleside Branch Library to public library direct service use for  
15 a period of forty years following completion of the project, regardless of any operating  
16 agreements the City may have with other jurisdictions or parties.
