3 **Resolution appointing Jennifer Friedenbach, Gail Gilman, Barry Hermanson, Leon**
4 **Winston and Marcia Argyris, terms ending May 15, 2004 to the Local Homeless**
5 **Coordinating Board. Residency requirement waived.**

7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
8 does hereby appoint the hereinafter designated persons to serve as members of the Local
9 Homeless Coordinating Board, pursuant to the provisions of Resolution No. 827-97 and
10 Resolution No. 926-99, for a two year term:

11 Jennifer Friedenbach, succeeding herself, term expired, seat 4, must represent area of
12 advocacy, for the unexpired portion of a two year term ending 5/15/04.

13 Gail Gilman, succeeding herself, term expired, seat 6, must be a service provider, for
14 the unexpired portion of a two year term ending 5/15/04.

15 Barry Hermanson, succeeding himself, term expired, seat 8, must represent the
16 business community, for the unexpired portion of a two year term ending 5/15/04.

17 Leon Winston, succeeding Laura Ware, term expired, seat 9, must represent education
18 and/or training, for the unexpired portion of a two year term ending 5/15/04.

19 Marcia Argyris, succeeding herself, term expired, seat 10, must represent a foundation,
20 for the unexpired portion of a two year term ending 5/15/04 (residency waiver required); and
21 be it

22 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 23 1. The membership of the Local Homeless Coordinating Board has a goal to be
24 representative of the diversity of the City and County of San Francisco.

- 1 2. Applicant Marcia Argyris, who is not a resident of San Francisco, is a person with
2 experience that uniquely qualifies him/her to serve on the Local Homeless
3 Coordinating Board.
- 4 3. The Local Homeless Coordinating Board has attempted to fill the position, for which
5 Marcia Argyris was nominated, with an individual who is a City resident and who
6 has the specific experience, skills, and qualifications, but has been unable to do so
7 at this time. The Rules Committee has certified that Marcia Argyris is qualified to
8 serve on the Local Homeless Coordinating Board.
- 9 4. After exercising due diligence, the Board of Supervisors concludes that there is no
10 other possible representative, who is a resident of San Francisco and who has the
11 specific experience, skills, or qualifications possessed by this applicant, and who is
12 willing to serve on the Local Homeless Coordinating Board at this time; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors waives the residency
14 requirement for Marcia Argyris, as allowed in cases where no qualified City resident, willing to
15 serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)
16 appointed to boards, commissions, and advisory bodies established by legislative act of the
17 Board of Supervisors to be resident(s) of the City and County of San Francisco.




