3 **Resolution certifying the Determination of the Office of Environmental Review that no**
4 **further environmental review document is necessary for the West Field Cargo**
5 **Redevelopment Project at San Francisco International Airport.**

7 WHEREAS, The Board of Supervisors has previously reviewed the 1992 San
8 Francisco Master Plan Program EIR ("EIR"), prepared by the City and County of San
9 Francisco Office of Environmental Review ("OER") and certified by the San Francisco
10 Planning Commission on May 28, 1992, all in accordance with the requirements of the
11 California Environmental Quality Act, Cal. Public Resources Code Sec. 21000 et seq
12 ("CEQA"); title 14, Section 15000 et seq. of the Code of California Regulations ("CEQA
13 Guidelines") and Chapter 31 of the San Francisco Administrative Code; and

14 WHEREAS, The West Field Cargo Redevelopment Project ("Project") is a project
15 included in the Master Plan, and is described generally in the Master Plan and analyzed in the
16 EIR; and,

17 WHEREAS, Section 15168 of the CEQA Guidelines requires subsequent activities in a
18 program that are covered by a program EIR be examined in light of the program EIR to
19 determine whether additional environmental documentation must be prepared; and,

20 WHEREAS, After reviewing the information regarding the Project, OER prepared an
21 addendum to the Master Plan Program EIR, dated August 22, 2003, to address the changes
22 to the Project to specifically evaluate the impacts of the modifications and concluded that the
23 modified Project was within the scope of the Master Plan Program, and that no supplemental
24 EIR or negative declaration was required; and,




