9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Making Environmental Findings. The Planning Department has determined that the
11 actions contemplated in this Ordinance are in compliance with the California Environmental Quality
12 Act (California Public Resources Code sections 21000 et seq.). Said determination is on file with the
13 Clerk of the Board of Supervisors in File No. 031274 and is incorporated herein by reference.

14 Section 2. The San Francisco Park Code is hereby amended by adding Section 12.34, to read
15 as follows:

16 Sec. 12.34. Admission Fees for the Conservatory of Flowers.

17 (a) The following admission fees shall be charged for admission to the Conservatory of
18 Flowers:

<u>Age Category</u>	<u>Rate</u>
<u>Adults:</u>	<u>\$5.00</u>
<u>Youth 12-17 and Seniors 65 and over:</u>	<u>\$3.00</u>
<u>Children 5-11:</u>	<u>\$1.50</u>
<u>Children 4 and under:</u>	<u>no fee</u>
<u>San Francisco school groups K-12 with prior scheduling:</u>	<u>no fee</u>

2 month and on sponsored special event days.


