14 payment of \$500,000. The lawsuit involves alleged elder abuse, patients’ rights violations,
15 medical negligence, and wrongful death.

16 Section 2. The above-named action was filed in San Francisco Superior Court on
17 September 28, 2023, and the following parties were named in the lawsuit: plaintiffs Lan Pham,
18 Quyen Jennifer Pham, Mai Pham, Ly Pham Rivera, Henry Pham, And Linda Pham; defendant
