RECOMMENDATIONS – HOMELESSNESS

- 30% of Income Rent Cap in Permanent Supportive Housing
 - Fund from General Fund, not OCOH
 - Expenditures: **\$6,000,000** from General Fund, annually
 - Savings: **\$6,000,000** in OCOH, annually
- TAY Navigation Center – Supportive Services
 - Fund additional services, physical plant expansion
 - Expenditures: approx. **\$1,000,000**, annually
 - \$793,000 ask from 3rd Street Youth Center and Clinic (provider) + 2 FTE

RECOMMENDATIONS – HOMELESSNESS AND POLICING

- Compassionate Alternative Response Team
 - Fund by cuts from SFPD
 - Expenditures: **\$6,825,000** from General Fund, annually
 - Savings: corresponding cut of **\$6,825,000** from SFPD
- Adjust SFPD and Sheriff Budgets
 - Reduce SFPD & Sheriff budgets: closure of County Jail #4, SCRT, non-Sheriff safety at DPH
 - Savings: **several million**, carried over

RECOMMENDATIONS – DCYF AND MTA

- Support Youth Organizing
 - Fee waivers for youth-led events, grants for youth organizing
 - Expenditures: variable, approx. **\$500,000**, annually

- Youth Transportation Advisory Board
 - Continue funding for YTAB
 - Expenditures (MTA): **\$290,200**, annually
 - Stipends: \$10,200, annually
 - Staff support: \$280,000, annually (supports cumulative 2 FTEs)

RECOMMENDATIONS – FREE MUNI

- Free Muni Pilot
 - Pilot Free Muni, increase service during the fall as students return to school
 - Expenditures: **\$12,500,000** (or more) in conditioned General Fund support to MTA budget
- Permanent Free Muni for All Youth
 - Eliminate the nominal fare for all youth
 - Expenditures (MTA): up to **\$2,000,000**, annually

RECOMMENDATIONS – JUVENILE PROBATION

- Remove Funding that Keeps Juvenile Hall Open
 - Remove funding for Juvenile Hall in second half of FY 2021-2022 and FY 2022-2023
 - Savings: **\$8,438,639.5** in FY 2021-2022, **\$18,805,300** in FY 2022-2023
- Remove Proposed Funding For Log Cabin Ranch
 - Keep facility in southern San Mateo County closed
 - Savings: **\$2,644,157** in FY 2021-2022, **\$2,676,755** In FY 2022-2023
