8 issues and a quarter century as the founder and driving force behind Hermanson's
9 Employment Services with the unwavering goal of improving the lives of the people of San
10 Francisco; and

11 WHEREAS, Barry had the laudable vision and perseverance to cultivate and nurture
12 an enterprise that supported better workplaces beneficial to businesses, their employees, and
13 the communities in which they reside; and,

14 WHEREAS, Based on this principle Barry has worked tirelessly to provide a livable
15 wage to temporary workers employed by his company without charging clients more; and,

16 WHEREAS, Barry has generously invested business profits back into the community
17 through donations to over 40 organizations ranging from Dolores Street Community Services
18 and the Small Business Network to United for a Fair Economy; and,

19 WHEREAS, Barry and his staff have graciously welcomed progressive campaigns with
20 shoestring budgets to utilize their office space and phones; and,

21 WHEREAS, Barry was instrumental in organizing the living wage movement and
22 fought for the new minimum wage, which enabled over 74,000 low-wage workers to improve
23 their standard of living and over 20,000 workers to benefit from the stability health care
24 insurance provides; and

2 wishes to Barry Hermanson; and

3 WHEREAS, Barry opened the doors of Hermanson's Employment Services on March


