

1 [Agreement - California Department of Health Care Services - County Children's Health  
Initiative Program - Up to \$397,405]

3 **Resolution retroactively authorizing the Department of Public Health to enter into a**  
4 **six-month agreement with the California Department of Health Care Services to receive**  
5 **reimbursement for children enrolled in the Healthy Kids Program, and expend funds in**  
6 **the amount of up to \$397,405 to finance the program for the period of January 1, 2015,**  
7 **through June 30, 2015.**

9 WHEREAS, On July 1, 2014, the Managed Risk Medical Insurance Board (MRMIB)  
10 ceased operations as a result of the Budget Act of 2014 and all MRMIB programs transitioned  
11 to the California Department of Health Care Services (DHCS); and

12 WHEREAS, The County Children's Health Initiative Program (C-CHIP), formerly  
13 administered by MRMIB, transitioned to DHCS, and provides federal reimbursement to  
14 counties for health care to eligible children; and

15 WHEREAS, The City and County of San Francisco ("City") serves these children  
16 through the Healthy Kids Program ("Program"); and

17 WHEREAS, Healthy Kids enrollees eligible for federal reimbursement include  
18 documented U.S. residents and citizens up to age 19, who are between 266% and 322% of  
19 the federal poverty line and reside in the City; and

20 WHEREAS, San Francisco and other participating counties will be able to bill DHCS  
21 and collect funds for children enrolled as of January 1, 2015; and

22 WHEREAS, Depending upon the availability of federal funding for California, the  
23 C-CHIP Reimbursement Agreement ("Agreement") may be renewed for periods beyond June  
24 30, 2015; and

1           WHEREAS, This Agreement, for an estimated \$397,405 according to the proposed  
2 agreement sent by DHCS, includes payments retroactive to January 1, 2015, and estimated  
3 payments through June 30, 2015; and

4           WHEREAS, DPH was previously responsible for advancing the 35 percent non-federal  
5 share of incurred costs, effective January 1, 2015, the State of California will advance the  
6 non-federal share, resulting in no impact to the anticipated federal reimbursement amount;  
7 now, therefore, be it

8           RESOLVED, That DPH is hereby retroactively authorized to enter into the Agreement  
9 with DHCS in the amount of \$397,405, for the period of January 1, 2015, to June 30, 2015;  
10 and, be it

11           FURTHER RESOLVED, That the Director of Health or her appointed representative is  
12 authorized to sign the agreement on behalf of the City, and, be it

13           FURTHER RESOLVED, That DPH is authorized to expend these funds on the  
14 Program; and, be it

15           FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed  
16 by all parties the Department of Public Health shall provide the final contract to the Clerk of  
17 the Board for inclusion into the official file.


