[Initiating Landmark Designation - Gilbert Baker's Rainbow Flag Installation at Harvey Milk Plaza1

Resolution initiating a landmark designation under Article 10 of the Planning Code of Gilbert Baker's Rainbow Flag installation at Harvey Milk Plaza at the southwest corner of the intersection of Market Street and Castro Street.

WHEREAS, Under Planning Code, Section 1004.1, the Board of Supervisors may by Resolution initiate a landmark designation; and

WHEREAS, Gilbert Baker's Rainbow Flag installation at Harvey Milk Plaza has been an invaluable neighborhood asset in District 8 for over 26 years and contributes to the unique arts and culture of San Francisco; and

WHEREAS, San Francisco is the birthplace of the rainbow flag in 1978; and WHEREAS, The rainbow flag has become a global symbol for the LGBTQ+ community, while the Rainbow Flag is an artwork created by Gilbert Baker; and

WHEREAS, On November 8, 1997, this Rainbow Flag was installed to commemorate the 20th anniversary of the election of Harvey Milk to the San Francisco Board of Supervisors, this victory by an openly gay man was a watershed for the gueer rights movement, since then, open members of the LGBTQ+ community have been elected to many levels of public office throughout the United States; and

WHEREAS, After Milk's election on November 8, 1977, many members of San Francisco's LGBTQ+ community have been elected or appointed to office; and

WHEREAS, Gilbert Baker's Rainbow Flag installation at Harvey Milk Plaza is a political artwork; and

WHEREAS, Since its installation, this Rainbow Flag, a site-specific artwork designed by Gilbert Baker, a queer artist who had lived in San Francisco; has flown for 24-hours a day year-round; and

WHEREAS, The artwork consists of a 6-striped banner, flagpole and metal plaque; and WHEREAS, Gilbert Baker is recognized as an important political artist; his six-color Rainbow Flag is in the permanent collections of the Museum of Modern Art, the London Design Museum, the Tang Museum, the Barack Obama Presidential Library in Chicago, the Philadelphia Art Museum and many more esteemed institutions; and

WHEREAS, Gilbert Baker created many monumental rainbow flags, but the Rainbow Flag at Harvey Milk Plaza remains Baker's sole permanent installation; and

WHEREAS, Gilbert Baker's Rainbow Flag installation at Harvey Milk Plaza has become a physical beacon of pride and self-empowerment - for both the residents of San Francisco and for visitors from around the world; and

WHEREAS, The LGBTQ+ community is under attack; as right-wing activists and legislators threaten trans rights and LGBTQ+ books and curricula, with more than 50 towns and school districts across the United States have banned the Rainbow Flag - seven in California alone; and

WHEREAS, Gilbert Baker's Rainbow Flag installation at Harvey Milk Plaza deserves recognition as a historically significant art installation; and

WHEREAS, The Gilbert Baker Foundation spurred interest for Landmark Designation for Article 10 Landmark Designation for Gilbert Baker's Rainbow Flag installation at Harvey Milk Plaza; and

WHEREAS, As the birthplace of this global symbol, San Francisco can ensure that this beacon of hope flies, 24 hours a day, every day of the year, in perpetuity, in defiance of those

who wish to erase sexual and gender minorities from the rainbow of humanity; now, therefore be it

RESOLVED, The Board of Supervisors hereby initiates landmark designation of Gilbert Baker's Rainbow Flag installation at Harvey Milk Plaza, under Planning Code, Section 1004.1; and, be it

FURTHER RESOLVED, The Board requests that the Planning Department prepare a Landmark Designation Report to submit to the Historic Preservation Commission for its consideration of the full historical, architectural, aesthetic, and cultural interest and value of Gilbert Baker's Rainbow Flag installation at Harvey Milk Plaza; and, be it

FURTHER RESOLVED, The Board of Supervisors requests that the Historic Preservation Commission consider whether Gilbert Baker's Rainbow Flag installation at Harvey Milk Plaza warrants landmark designation and submit its recommendation to the Board according to Article 10 of the Planning Code.
