7 who has dedicated his entire United States immigration experience in raising the quality of life
8 for low-income San Franciscans; and

9 WHEREAS, Enoch Fung will retire, after serving for over a decade at Chinatown
10 Community Development Center as its most experienced and well-known Senior Resident
11 Services Coordinator; and

12 WHEREAS, He has been an inspirational mentor, modeling and resourcing his
13 colleagues to build community, provide opportunities and connections, and empower and
14 organize low-income tenants; and

15 WHEREAS, Enoch Fung immigrated from Hong Kong as a decorated social services
16 and business professional; is an alumnus of Chinese University of Hong Kong, with a
17 Bachelors in Social Work and Masters of Business Administration; and

18 WHEREAS, Enoch Fung is one of the earliest social work professionals in the field of
19 Hong Kong social welfare policy; and

20 WHEREAS, He built upon these civic values in his work as a Housing Officer at Hong
21 Kong Housing Authority; Social Services Manager and Superintendent at Hong Kong Yan
22 Chai Hospital; Manager at Windows to China Hong Kong Ltd.; Trading Executive at Plasmark
23 Co. Ltd.; Executive Officer at Challenge Ventures; Controller at Hong Kong Telephone Co.


