13 WHEREAS, In July 2016, the Panel released its final report on the findings and  
14 recommendations of the Panel; and

15 WHEREAS, On October 4, 2016, the Board of Supervisors, sitting as a Committee of  
16 the Whole, held the first hearing on the final report and heard testimony from members of the  
17 Panel and Police Department staff; and

18 WHEREAS, the Blue Ribbon Panel on Transparency, Accountability, and Fairness in  
19 Law Enforcement made over 80 police reform recommendations; now, therefore, be it

20 MOVED, The Clerk of the Board of Supervisors is directed to schedule Committee of  
21 the Whole hearings on the first Regular Meeting of the Board of Supervisors every third month  
22 beginning in February 2017, to hear and receive an update on the final report, findings, and  
23 implementation of the recommendations of the Blue Ribbon Panel on Transparency,  
24 Accountability, and Fairness in Law Enforcement, and requesting the Police Department and  
25 Police Commission to report.
