**Re: Technical Adjustments Round 1 to the Mayor's Proposed Budget**

Dear Chair Chan,

Per Charter Section 9.101, I am submitting the attached adjustments to the Mayor's Proposed Budget for FY 2023-24 and FY 2024-25.

Technical adjustments include:

- Correcting the pay period start date for a new position in the Department of Public Health;
- Correcting expenditure, project, authority, and account codes for the Department of Public Health;
- Correcting a revenue code for the Department of Building Inspection;
- Correcting a work-order recovery for the Sheriff's Department of Accountability;
- Shifting \$500,000 in funds for the Legislative Management System project in the Board of Supervisors from FY 2024-25 to FY 2023-24.

This set of technical adjustments will grow the FY 2023-24 budget by \$424,087 and is at a cost of \$504,087 in FY 2023-24 and a savings of \$460,000 in FY 2024-25. Over the two years the net impact will be a general fund cost of \$44,087. The attached table details these changes. Please contact me with any questions or concerns.
