3 **Resolution urging the California State Legislature explore ways to significantly**  
4 **strengthen Workers Compensation benefits for California employees.**

5 WHEREAS, Workers Compensation benefits are the primary remedy for employees  
6 who suffer job-related injuries in California; and

7 WHEREAS, the majority of injured workers in California receive permanent disability  
8 benefits at a level of \$140 a week, and;

9 WHEREAS, this benefit level has remained unchanged for the last eighteen years,  
10 represents a salary level of less than half of the federal poverty level for a family of four, and  
11 ranks California 49th out of 50 States in the level of permanent disability benefits; and;

12 WHEREAS California is only one of seven states in the US that has failed to adopt the  
13 recommendations of a 1972 Federal Commission on the Adequacy of Temporary Disability  
14 Benefits, and;

15 WHEREAS, Governor Gray Davis has twice vetoed legislation to expand benefits to  
16 injured workers, suggesting that increases in Workers Compensation benefits would  
17 adversely impact the State's economy, and;

18 WHEREAS, Workers Compensation costs to employers actually represent less than  
19 two percent of total State payroll, and statutory changes in California law enacted in 1993 and  
20 1994 have further reduced those costs by more than one-third a year, resulting in State  
21 employers realizing nearly \$4 billion a year in savings, with continued savings projected into  
22 foreseeable future, and; now, therefore, be it

FURTHER RESOLVED, That City and County of San Francisco Board of Supervisors urges both the Legislature and the Governor to avoid enacting any laws in current and future legislative terms that reduce or eliminate Workers Compensation benefits, restrict employees' legal rights regarding these benefits, or impede employees' ability to establish their claims and receive benefit payments in a timely manner.




