Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the Coalition on Homelessness' claims in the action entitled Coalition on Homelessness, et al. v. City and County of San Francisco, et al., United States District Court for the Northern District of California, Case No. 4:22-cv-05502-DMR on substantially the same terms as set forth in the Settlement Agreement on file with the Clerk of the Board of Supervisors in File No. 250767, which is incorporated by reference and declared to be a part of this ordinance as if set forth fully herein. The Settlement Agreement includes the payment of \$2,828,000 in attorney's fees and costs, as well as an agreement concerning the treatment of property belonging to persons experiencing homelessness. The lawsuit involves Plaintiff's allegation that the City unlawfully seizes property of persons experiencing homelessness without adequate advanced notice, discards property the City should store

under the terms of the City's "bag and tag" policy, and fails to store property of persons experiencing homelessness in a way that allows successful retrieval of their property.

Section 2. The above-named action was filed in the United States District Court for the Northern District of California on September 27, 2022, and the following parties were named in the lawsuit: Plaintiffs Coalition On Homelessness; Toro Castaño; Sarah Cronk; Joshua Donohoe; Molique Frank; David Martinez; Teresa Sandoval; Nathaniel Vaughn, and Defendants City and County Of San Francisco; San Francisco Police Department; San Francisco Department of Public Works; San Francisco Department of Homelessness and Supportive Housing; San Francisco Fire Department; San Francisco Department of Emergency Management.
