11 Home Supportive Services to eligible blind, aged, and disabled persons to enable these
12 individuals to remain safely in their homes; and,

13 WHEREAS, The Human Services Agency conducted a Request for Proposal for these
14 services in January 2005; and,

15 WHEREAS, The IHSS Consortium of San Francisco submitted a responsive and
16 responsible proposal and was awarded the contract; and

17 WHEREAS, The Human Services Commission has recommended approval of this
18 contract to the IHSS Consortium of San Francisco at its meeting of June 10, 2005; and

19 WHEREAS, The Board of Supervisors has approved award of this contract to the IHSS
20 Consortium of San Francisco for the period of July 1, 2005 to June 30, 2008, in the amount of
21 \$51,433,291 on August 18, 2005;

22 WHEREAS, The Aging and Adult Services Commission has recommended approval of
23 this amendment to IHSS Consortium contract for an additional amount of \$21,679,795 for the
24 period from July 1, 2008 to June 30, 2009 at it's regular meeting of June 4, 2008 now
25 therefore, be it
