11 of \$110,000, representing the claim for diminution of property value, and excluding attorney's  
12 fees, costs and interest, which will be addressed in later proceedings.

13 Section 2. The above-named action was filed in San Francisco Superior Court on  
14 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiff KLW,  
15 LLC and Defendant City and County of San Francisco.
